The maximum number of additional hours is defined in the individual or collective employment contract. There may be exceptions for up to 4 months, for the employee to work for more than 48 hours, with the condition that the average weekly working hours for this period should not exceed 48 hours. The maximum limit for all types of works is no more than 200 hours per year. With the authorization of the Labour Inspectorate, the maximum number of additional hours may be exceeded in special cases for the benefit of the population.
